Greenways HOA Board of Directors Meeting

The latest Board of Directors meeting was held on Thursday, June 24th. In attendance were Pres. Amy Hamilton, VP Kimberly Warminski, Developer Eddie Scott, Board Members Patti Ward, Sonny Moore, Jim Worthington, and HOA Manager Phyllis Weiss.

Agenda items included the review/approval of minutes from the May 5, 2010 board meeting, review/approval of the financial reports, a report on the plans for the 2010 Annual HOA Picnic, a security update, discussion about tree replacement and lawn maintenance, park lighting, and homeowner dues collection.

Eddie Scott will be meeting with Larry Offerdahl, City Parks and Recreation Department, regarding lighting for the Greenways Park and Nature Area. Eddie will provide the Board an update from this meeting.

The Board approved the plan and budget for the 2010 Annual Picnic presented by committee chairman Patti Ward.

The Board approved continued periodic security patrols by off-duty police officers. Dates were set for July and August patrols.

The Board reviewed the progress on tree replacement. A large percentage of the trees targeted for replacement have already been replaced and the Board agreed to continue to monitor the situation and send out second notice letters as needed.

The collection of Homeowner Dues was discussed. It was determined that further action needs to take place to increase the collection of these dues.

The next Board of Directors meeting is set for Thursday, July 22, 2010 at 6:30 pm. There being no further business, the meeting was adjourned.

According to the US Census Bureau the average annual HOA dues in the US are \$420 for single-family homes and \$2,400 for condos. That makes the Greenways HOA Dues of \$39 per Lot look pretty good.

Your Pet is Your Responsibility

This is a subject that is dear to my heart and seems to be one we have to address on an "all to often basis". If you own a pet in the Greenways, you must abide by the City Ordinances as well as our own Covenants and Restrictions.

Pets add so much to our family life. They love us unconditionally, they are loyal, and if they are able, they would protect us with their own lives (speaking primarily about dogs here...cats are another matter all together). But they depend on you to be responsible and take care of them to the best of your ability.

The main complaints we receive here at the HOA are, barking dogs, cats allowed to run free, and dogs allowed to run unleashed.

First of all, according to the Covenants and Restrictions you are allowed to have up to two "outdoor pets" per Lot and you are expected to pick up after them and keep them from being a nuisance. That includes but not limited to excessive barking.

Article 2 of the Covenants and Restrictions says the pets must be restrained. That means cats too. I know cats are independent creatures, but you are not supposed to allow your cats to run free any more than you do your dogs. The City of Amarillo Ordinance says you **must** leash your animals or risk having them picked up by Animal Control.

Unleashed Pets Can Also Effect Your Property Values...

I know those of you who do not own pets are getting a little tired of hearing this and you think it does not effect you. However, if the Greenways develops a reputation as a community with too many unleashed pets you could see an effect on all the property values. This is everyone's problem. The Covenants and Restrictions are in place to help elevate the property values in all of the Greenways. Please be a responsible Owner and understand adhering to the C & R's benefits the community as a whole.

For those of you who have paid your dues...Thank You. For those who have not, please understand **they are not optional**. They are mandatory.

Please do not force the Board of Directors to take further action, which could include a lien against your property.

If too many homeowners stop paying their HOA fees, lenders may be unwilling to make mortgages or refinance properties in the community, and that can hurt property values.

Why a Leash Law?

- Pets at large are often killed or severely injured by cars.
 - Pets at large often attacked or are attacked by wild animals.
 - Pets at large often bite other pets that are in their own yard, and often bite children playing or people on bicycles.
 - Pets at large are unlawful nuisances.
 - Pets at large are often sickened by eating spoiled garbage, antifreeze, etc.
 - An unleashed dog at large can easily run up to an aggressive but leashed dog and cause a confrontation wherein the leashed dog will have to be released to defend itself.
 - Pets at large can be lost or stolen.

Bulky Trash Pick Up

When you have large items that won't fit into the dumpster you may arrange for special collection by calling the City of Amarillo Solid Waste Department at 378-6813.

The City operates a fixed-route brush collection service for tree trimmings and other brush. Please call the same number to find out when they plan to be in your area before discarding large items or your trimmings.

There is also a brush/tree limb collection site at 7500 S. Soncy Rd. available for residents to deposit tree limbs and brush. These are ground up to wood chips and are free for public pickup.

Neighborhood Watch Tip....

Put your car keys beside your bed at night..

If you hear a noise outside your home or someone trying to get in your house, just press the panic button for your car. The alarm will be set off, and the horn will continue to sound until either you turn it off or the car battery dies, hopefully scaring off a would-be intruder.



So the next time you come home for the night and you start to put your keys away, think of this, and set them beside your bed instead. It's a security alarm system that you probably already have and requires no installation. Test it.
